## Section D Personal Flotation Devices

### **IMPORTANT: Refer – Club Sailing Instruction**

- It is a condition of sailing at the Club that an approved Personal Flotation Device (i.e. Lifejacket or Buoyancy vest in good repair) shall be worn at all times while on the water.
- The instructions of the Race Officer shall be complied with at all times.

#### **Please note:**

1. Unless stated otherwise or alternative arrangements have been made with the Treasurer, annual subscriptions and boat storage fees must be paid by **31 October 2018**. If storage fees not paid by due date, unfinancial members will have **30 days to remove** their boat from the Club's storage areas.
2. Canterbury Yachting Association levies are incorporated in your Club Subscriptions.
3. If you have any enquiries regarding Subscriptions or Boat Storage Fees, please contact the Treasurer.

#### **BOAT STORAGE CONDITIONS:**

1. Boat storage space is limited and will be offered to financial members (i.e. on receipt of 2018-2019 subscription fees). Priority will be given to those who sail regularly.
