### IMPORTANT: (Refer – Club Sailing Instructions)

1. It is a condition of sailing at the Club that an approved **Personal Flotation Device** (i.e. Lifejacket or Buoyancy vest in good repair) **shall be worn at all times** while on the water.
2. The instructions of the Race Officer shall be complied with at all times.

## SECTION E: Notes and Conditions

### 1. SUBSCRIPTIONS & FEES:

- 1.1. Unless stated otherwise or alternative arrangements have been made with the Membership Convenor, annual Subscriptions, Affiliation Fees and Boat Storage fees must be paid by **31 October 2021**.
- 1.2. Membership Period: **1 September 2021 to 31 August 2022**.
- 1.3. Canterbury Yachting Association levies are incorporated in your Club Subscriptions.
- 1.4. Please contact the Membership Convenor if you have any Subscription or Boat Storage Fee enquiries.

### 2. BOAT STORAGE CONDITIONS:

- 2.1. Boat storage space is limited and is only offered to financial members (i.e. on receipt of 2021-2022 subscription fees). Priority will be given to those who sail regularly.
- 2.2. Boat Storage Period: **1 September 2021 to 31 August 2022**.
- 2.3. If Boat Storage fees are not paid by the due date, members will have **30 days to remove** their boat(s) from the Club's storage areas.
- 2.4. It is the responsibility of boat owners to insure their boats and any equipment kept on club premises. WSC will not accept liability for loss or damage to boats or equipment stored on club premises or the adjacent section.
- 2.5. Road trailers are not permitted in storage sheds.
